

LETTER OF INTENT

This Letter of Intent (hereinafter: “**Letter of Intent**”) concluded on 3.07.24, between:

1. **Ogólnopolską Izbę Gospodarczą Wyrobów Medycznych POLMED**, with its registered office in Warsaw, at T. Chałubińskiego 8 Street, 00–613 Warsaw, Poland;
2. **CzechMed Česká asociace dodavatelů zdravotnických prostředků**, with its registered office in Prague, at Letenská 8 Street, 118 00 Prague, Czech Republic;
3. **MedTech Slovenija Zbornica ponudnikov medicinske tehnologije in storitev**, with its registered office in Ljubljana, Dimiceva 13 Street, 1504 Ljubljana, Slovenia;
4. **SK+MED Slovenská asociácia dodávateľov zdravotníckych pomôcok**, with its registered office in Bratislava, at Seberinho 9 Street, 821 03 Bratislava, Slovakia;
5. **Orvostechnikai Szövetség Association of Medical Devices Manufacturers**, with its registered office in Budapest, Tímár 21 III/1 Street, 1034 Budapest, Hungary;
6. **ETOSZ Egészségügyi Technológia és Orvostechnikai Szállítók Egyesülete**, with its registered office in Budapest, Felhevi 5 Street, 1023 Budapest, Hungary;
7. **MedTech Bulgaria**, with its registered office in Sofia, 15 Ivan Denkoghlu St Ah, Sofia, Bulgaria.
8. **CROMED** – Udruga Industrije Medicinskih Proizvoda with its registered office in Zagreb, Radnička 80, 10000 Zagreb, Croatia

hereinafter referred to as the “**Party**” or “**Parties**”.

WHEREAS the Parties, as organizations representing the professional, social and economic interests of companies operating in the medical device market and entities working for the development of better and more effective solutions in the field of health care, are interested in undertaking cooperation within the scope and on the terms set forth in this Letter of Intent, the Parties have decided to conclude an agreement with the content as follows.

§ 1.

1. The Parties, through the signing of the Letter of Intent, express their will to cooperate in good faith and jointly achieve the objectives of:
 - a. seeking solutions based on scientific knowledge and world best practices that contribute to the development of the law in individual Member States and the European Union in a manner that may have an impact on improving the situation of patients or the healthcare system in the area of medical devices and in vitro diagnostic medical devices (hereinafter: “**medical devices**”);
 - b. developing educational initiatives that will advance the knowledge and practice of medical devices and strengthen international cooperation and collaboration with healthcare professionals and healthcare organizations, in order to achieve tangible benefits for patients, hospitals and the European healthcare system.

§ 2.

1. The Parties express their will that the objectives will be achieved through, among others:
 - a. mutual support for the provision of reliable information for the benefit of the healthcare system in individual Member States and at the European level;
 - b. joint educational activities concerning the medical device industry;
 - c. promotion of the idea of strengthening international cooperation in the area of medical devices;

- d. exchange of experience and knowledge between the Parties in the areas of statutory competence of the organizations;
 - e. other joint initiatives – as individually agreed.
2. The realization of individual objectives will always be carried out in accordance with all generally applicable laws and all procedures and policies of the Parties.
 3. The detailed principles and manner of realization of individual joint activities referred to above shall be established in separate agreements.
 4. This Letter of Intent shall not create any form of legal structure, nor shall it result in any financial obligations for any of the Parties.

§ 3.

1. This Letter of Intent is signed for an indefinite period of time.
